



Conservation League Donor Lucky Draw 2026

Terms and Conditions

1. Promoter

The promoter of this lucky draw is BirdLife South Africa.

2. Eligibility and Entry

This lucky draw is open to Conservation League Donors of BirdLife South Africa who are current and in good standing as of 30 June 2026. Employees, contractors, and board members of BirdLife South Africa or Melozhori Private Game Reserve, as well as their immediate family members (including spouses, life partners, parents, children, and siblings), are not eligible to participate.

3. Draw Date and Winner Selection

The draw will take place on 1 July 2026. The winner will be selected by random draw.

4. Winner Notification

The winner will be notified via telephone and/or email. If the winner cannot be contacted or does not respond within 7 days, BirdLife South Africa reserves the right to select an alternative winner.

5. Prize

The prize includes a two-night self-catering stay for two adults at Melozhori Eco Pods, including one game drive.

6. Prize Redemption

The prize must be redeemed by 19 January 2028 and is subject to availability.

7. Non-Transferable / Non-Refundable

The prize is non-refundable, not redeemable for cash, and cannot be exchanged for other services or accommodation. The prize may be transferred once only, at the discretion of the winner, to individuals selected by them.

Advance booking is required and is subject to availability at Melozhori Private Game Reserve.

All costs not expressly included in the prize are the responsibility of the winner.

BirdLife South Africa reserves the right to amend, suspend, or cancel the lucky draw at any time without prior notice, where reasonably necessary.

BirdLife South Africa and Melozhori Private Game Reserve accept no responsibility for any loss, injury, damage, or expense arising from participation in the lucky draw or use of the prize.

13. Force Majeure

BirdLife South Africa and Melozhori Private Game Reserve shall not be liable for any failure to deliver the prize or any part thereof due to circumstances beyond their reasonable control, including but not limited to natural disasters, pandemics, or other unforeseen events.
